



## **2020 RECREATION PROGRAM POLICIES**

### **Age Group Policy**

Placement in age groups will be determined by the participant's school grade starting in September, and in no instance may a child participate in an activity until he/she has reached the age of 4.

Pre-Kindergarten/Kindergarten children will be required to attend activity sessions with an Activity Buddy: a consistent parent, guardian, caregiver aged 16+. This Buddy must accompany the child to and from the activity as well as be available throughout the activity. The Saltaire Summer recreation staff can 'guide on the side' but will not be able to provide those 'helping hands' so the Activity Buddy will step in when needed. Please make every effort to send a consistent buddy, and please be aware that the buddy will be required to participate in the COVID health screening process.

### **Medical Coverage and Waiver with Covid-19 Waiver**

The Recreation Program provides limited accident insurance coverage for each child during participation in recreation activities. It is not in any way a substitute for family medical coverage and the Village strongly encourages that each participant should maintain their own sufficient medical coverage.

I as the parent or legal guardian give permission for emergency diagnostic and therapeutic or surgery as may be deemed necessary for my child by the medical

personnel in charge of care at the time; and I will also provide information concerning my child's medical condition to the responsible officials when deemed necessary. My child is in good health and has no COVID-related symptoms (described later herein) today and has my permission to enroll and participate. My child has no previous sickness, illness, disease or bodily injury which is in any way a constraint or restriction to his/her participation in the Saltaire Recreation Program`.

### **Covid-19 Waiver Language**

The novel coronavirus, Covid-19, has been declared a worldwide pandemic by the WHO. Covid-19 is extremely contagious and is believed to spread mailing from person to person contact. As a result, federal, state and local governments and health agencies required the wearing of face coverings and recommended social distancing and other measures and in some cases prohibited the congregation of groups of people. The Saltaire Recreation Program cannot guarantee that you or your child(ren) will not become infected with Covid-19 and participation in the Recreation Program could increase your risk of contracting Covid-19.

I acknowledge the contagious nature of Covid-19 and voluntarily assume the risk that I may be exposed to or infected by Covid-19 by participation; and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for injury to myself or my child(ren) including, but not limited to, personal injury, disability, and death, illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my participation in the Recreation Program. On my behalf, and on behalf of my child(ren) I hereby release, covenant not to sue, discharge, and hold harmless the Saltaire Recreation Program and the Village of Saltaire, its employees, agents, and representatives, of an from the claims, including all liabilities, claims, actions, damages, costs or expenses based on the actions, omissions, or negligence of the Recreation Program, its employees, agents, and representatives, whether a Covid-19 infection occurs before, during, or after participation in the Recreation Program.

I agree that to the best of their ability my child will follow all camp safety guidelines laid out by the Recreation Program and will attempt to practice safe social distancing and clean and proper hygiene at all times during participation in the Summer Program. Failure to comply with the provided safety guidelines will result in your child's expulsion from the Recreation Program.

### **Mandatory Health Screening and Covid Policy**

In order to offer this program and to comply with CDC recommendations and to maintain the safest possible environment, all recreation activities will operate under the COVID guidelines found at <http://www.saltaire.org/recsogs.pdf>.

An important requirement of these guidelines is that we are going to screen all participants and staff on a daily basis. This will consist of either a self-screening symptom-check certification or a contactless temperature screen.

The Saltaire Recreation Program reserves the right to require one or more of these screening and testing protocols:

- Participants and Staff will be required to follow a daily pre-screening protocol before contact with fellow staff or program participants.
- Anyone who is sick with anything (even sniffles) should stay home and if identified during the activity will be instructed to go home.
- Anyone who stays home, is sent home, or has symptoms of an illness must be tested prior to returning to any activity.
- Morning health and/or temperature screening of all participants and staff before joining their group.
- If anyone feels ill at recreation activity (with anything) parents will be contacted and child will be sent home ASAP.

The Village will take the following actions when a participant or staff member develops COVID-19 like symptoms while at recreation activities.

*Persons with possible COVID-19 symptoms will be directed to a quarantine area where they will remain until a parent or caregiver has arrived. If tolerated, the participant will be required to wear a mask to protect those in attendance. Staff that self-transport who are physically able to will be*

*expected to get home on their own and will be given information on seeking medical advice via telemedicine. If they exhibit any signs of difficulty breathing 911 will be called. Persons who have been sent home due to possible COVID-19 infection may return to Recreation Program when they provide a negative test result and all symptoms have resolved or as per local health official's guidelines.*

The Village will take the following action if there is a COVID-19 Positive Diagnosis

*If a participant or staff member reports they are COVID-19 positive, VOS will maintain the confidentiality of the individual at all times while mitigating the situation. The case will be reported to the Health Authorities and all families and staff of the individual's group will be notified immediately. All facilities that the individual came in contact with will be vacated, deep cleaned and disinfected per CDC guidelines. We expect all participants and staff who came in close contact with the infected individual will be required to quarantine at the direction of the local health authorities. Any persons classified as having proximate exposure would be required to self-monitor for symptoms for 14 days or as directed by the local health authorities.*

*The CDC defines close contact as interaction within 6 feet for more than 15 minutes. Contact tracing will be carried out by trained staff in conjunction with the Suffolk County Health Department.*

*A "proximate exposure" is defined as interactions greater than 6 feet from an infected individual within a shared space.*

The Village will require persons who test positive for COVID-19 to be isolated for a minimum of 10 days under the direction of the local health authorities.

## **Refund Policy**

Registration ends at 12pm on the Saturday prior to the activity week. If a parent or guardian alerts the Recreation Program office before 12pm on the Sunday prior to the activity week they will receive a 100% refund. If they alert the Recreation

office after Sunday at 12pm they will receive 50% refund. A full refund will be given if a family experiences a Covid-related absence that is confirmed with the Covid Safety Coordinator.

*BAD WEATHER: If light rain is in the forecast we will press on. If very stormy conditions are predicted, we will send a message by 8:15am that the program is cancelled for the day. ALL MONEY WILL BE REFUNDED FOR THE DAY'S ACTIVITIES*
